

Liability and Responsibility Agreement

The Chinese School of CAACF, Inc.

All students are expected to show respect for teachers, fellow students, personal property and the facilities of the Chinese School of CAACF, Inc. ("Chinese School").

I, the undersigned parent or legal guardian of _____, a student registered in any of the programs/classes offered by the Chinese School, do hereby acknowledge and assume full responsibility for the safety of myself, my children, any member of my family and any visitors accompanying me, while attending the programs/classes offered by the Chinese School. I acknowledge that I will carefully listen to and follow all instructions and precautions presented by representatives of the Chinese School.

I also agree to indemnify and hold the Chinese School, its officers, directors employees, agents, and/or duly authorized representatives, successors and assigns (the "Chinese School Entities") harmless of and from any loss, liability, damage, cost of attorney fees incurred by or caused by me or my children or by my participation or my child's participation at the Chinese School, including without limitation any claims for personal injury or personal property damage which may be incurred by me, my children, any member of my family, and any visitors accompanying me at the Winter Park 9th Grade Center, site of the Chinese School. I further agree to be fully responsible for any claims and damage caused by me, any member of my family, and any visitors accompanying me, to the personal property, equipment, and physical structure of the Winter Park 9th Grade Center, site of the Chinese School.

I certify that I am over the age of eighteen and I declare and represent that no promise, inducement or agreement not expressly made in this Liability and Responsibility Agreement has been made to me, and that this Liability and Responsibility Agreement contains the entire agreement between the Chinese School Entities and me and my child, and that the terms of this Liability and Responsibility Agreement are contractual and not a mere recital.

Parent Duty Agreement:

I understand that the Chinese School of CAACF, Inc. is a non-profit organization run by volunteers, and donation is always encouraged. As a parent, I am obligated to support the school and the Parent Teacher Association ("PTA"), including support of the PTA functions and participation in cleaning and school grounds patrol duties ("Patrol Duty"). If I am not able to carry out the mandatory Patrol Duty one week in each semester (for all class periods) or to find a substitute in my place, I will notify one of the PTA officers. I understand that I will forfeit the full amount of my deposit to the PTA fund for each absence of my duty regardless if such absence notification has been received by the PTA offices or not. The PTA can use my deposit for any purpose in its sole discretion.

This permission is given to the Chinese School Entities with the knowledge that it will be relied upon at substantial cost to the Chinese School Entities, and I agree on behalf of myself, my child, any member of my family's and any visitors accompanying me's, while attending the programs/classes offered by the Chinese School, name not to assert any claim against the Chinese School Entities and to release the Chinese School, its officers, directors, agents, employees, and duly authorized representatives from any and all claims of any nature whatsoever arising from their use by the Chinese School Entities.
